International Congress on Evidence-based Parenting Support (I-CEPS)

The Inaugural International Congress on Evidence-based Parenting Support (I-CEPS) was held June 6-9, 2023. It was hosted as an entirely virtual event by the Parenting and Family Research Alliance (PAFRA). The Congress had an overarching message that good parenting is the "clean water" of children's mental health, resilience, and wellbeing and the single most important potentially changeable protective factor influencing human development, with life-long effects. I-CEPS aimed to inspire global collective action to improve access for all parents to high-quality, evidence-based, and culturally appropriate parenting support, to benefit children and young people everywhere.
